The regular joint monthly meeting of the Board of Directors of the Southwest Metropolitan Water and Sanitation District ("Southwest") and the Board of Directors of the Platte Canyon Water and Sanitation District ("Platte Canyon") convened on Friday, November 18, 2022, at 8:30 a.m. in the Districts' office located at 8739 West Coal Mine Avenue, Littleton, Colorado 80123. Due to COVID-19 and related virus concerns, and for purposes of convenience, the meeting was also conducted virtually using Microsoft Teams. Any Board members who could not or was not comfortable physically attending, could attend by telephone or virtually. The web address and call-in information were included in the meeting notice so that interested members of the public could also attend. Although jointly conducted, a portion of the meeting pertained solely to one District or the other and, accordingly, at times only the vote of one Board or the other was required.

- **2.** Management Report. The manager referred the members of each Board to her written management report for the month of October 2022, a copy of which was included in the meeting packet. In addition to answering questions, as more particularly discussed below, the manager had the following updates:
- (a) <u>Administrative Activities.</u> The manager noted that this is a very busy time of year and that especially the administrative staff has been working on budgets including the budgets for not only Platte Canyon and Southwest, but also Valley, Bow Mar and the other districts that Platte Canyon contracts with for services.
- (b) <u>Valley Sanitation District Election</u>. The manager noted that the Valley Sanitation District de-Brucing question did not pass. The question passed within that portion of Valley Sanitation located within Denver, but the Arapahoe County residents of the District voted against the ballot measure in significant enough numbers to cause it to be defeated by approximately 55% against and 45% in favor. As a result of the defeat, the Valley Sanitation

District is looking at a substantial increase in its sewer fees, which at the present time are collected through the City of Englewood. Valley needs these revenues to finance a number of upcoming capital improvement projects. The manager and Platte Canyon staff are working to assist Valley in these efforts.

- (c) <u>Bow Mar Water and Sanitation District.</u> The Bow Mar Water and Sanitation District is undergoing a change in its accounting and financial advisor. Hanie & Company which previously did all of the accounting for Bow Mar is getting out of that business. The Bow Mar Water and Sanitation District is in the process of hiring a new firm which Cynthia Lane believes will work closely with Platte Canyon's staff which should improve the overall bookkeeping, budgeting and financial records for Bow Mar going forward.
- (d) <u>Insurance Renewals.</u> The Boards were advised that the Special District Property and Liability Pool is quoting both Platte Canyon and Southwest rates for property, commercial general liability and public officials liability rates that are 10-20% higher than previous years. A significant portion of the increase is attributable to the District's property insurance coverage because of the increased cost for replacing physical structures should there be a catastrophic event. In addition, the cost for cyber-security coverage is increasing as well. The final rates for Platte Canyon and Southwest have not been quoted, but a significant increase is anticipated.
- (e) <u>Englewood/Littleton Wastewater Treatment Plant.</u> The cities of Englewood and Littleton are currently evaluating the governance of their wastewater treatment facility which operates under the name of South Platte Renew. Both Englewood and Littleton are looking for ways to transfer governance of that facility to another governmental entity, such as an authority or possibly a Title 32 special district. The process of changing the governance and creating a new entity is complex and will be time consuming and potentially very expensive in terms of administrative and legal costs that will be incurred. The manager is monitoring the situation closely and will apprise the Boards at future meetings as Englewood and Littleton decide on a how they want to have the jointly owned wastewater treatment plant owned, operated, and managed in the future.
- (f) <u>Tap Fee Study.</u> In response to a question from Platte Canyon Director Swatek, Cynthia Lane described the reasons why and the process that will be involved in obtaining a third-party independent review of both Platte Canyon's and Southwest's tap fees going forward. There have been minor changes in the methodology that has been used historically. Further, it was noted that for staff to recreate the methodology that had been previously followed would be difficult due to certain record keeping gaps. In any event, it is anticipated that a firm that specializes in evaluating and determining appropriate tap fees would be presented to both Boards during the first quarter of 2023.
- 3. <u>Operations and Maintenance Summary Report</u>. Scott Hand reviewed the Operations and Maintenance Summary report for October 2022. During the reporting period, neither Platte Canyon nor Southwest experienced any sanitary sewer service interruptions. Platte Canyon did not experience any water service interruptions; however, Southwest

experienced a water service interruption on October 5, 2022, which involved a beam break on a 6" asbestos cement pipe in the general location of 7056 South Ammon Street. The exact location of the break was hard to determine at first. As a result, there was a much longer excavation in the road then would normally occur. It took about 35 hours of time for C&L Water Solutions to fully repair the break. Approximately 35 customers were out of service for a number of hours. This is in an area where there is a lot of expansive soils, however, it is the first break Southwest has experienced on this line.

Mr. Hand also reviewed for the Boards, the various ongoing training that field and office staff is undergoing at the present time, including an active shooter training, which unfortunately is a necessity in this day and age.

Finally, Mr. Hand noted that the District has hired a new certified operator who has significant experience and appears to be working out well. It is hoped that he can be introduced to the Board at a future meeting.

4. <u>Capital Projects Report</u>. Tony Cocozzella reviewed the Capital Projects Report for Platte Canyon and Southwest for the month of October 2022. As part of his report, Mr. Cocozzella updated the Boards as to the status of all ongoing Platte Canyon and Southwest projects, including developer and District-specific projects. With regard to the relocation of Southwest's 16" water line in South Santa Fe Drive from C470 to Dad Clark Gulch, Mr. Cocozzella reviewed four options for relocating the line and indicated that at the present time there is some uncertainty as to who owns title to the property or across which these proposed routes would extend.
